2018 HIGHLIGHTS

Fighting H.A.R.D. is more than supporting an annual gala, it is supporting families, and believing pedestrian hit and run fatalities are a public safety concern.

MISSION STATEMENT

Fighting H.A.R.D. is a 501c3 organization established to raise awareness, educate, and provide resources to families impacted by hit and run fatalities.

There are serious consequences for drivers who leave the scene of an accident. Often families of victims suffer potential long-term physical and emotional impact which can have significant financial implications on the family.

OBJECTIVES

Fighting H.A.R.D. (Fighting Hit And Run Driving)
Year 1 through Year 3:

- Emphasize existence of hit and run problem.
- Determine scope of hit and run problem
- Estimate annual number of hit and run crashes.
- Provide support and resources to families of victims directly impacted by the fatalities.
- Establishing a college scholarship in the name of Jameca Stanfield
- Advocate for a Change Hit and Run Laws in the State of Missouri

- Provide resources to families
- Establish community partnered resources
- Raise Awareness to the cause
- Educate on pedestrian safety and prevention programs

YIELDING RESULTS OF 187 ATTENDEES IN OUR FIRST YEAR!!! In **2017**, **98 pedestrians** were killed in the state of Missouri.

Fighting H.A.R.D. identified **22** pedestrians killed by hit and run driving.

A tribute was given to 10 victims at the Annual Families Impact Gala on April 12, 2018. Each family received dinner, support and an honor in the name of the H.AR.D. victim at no charge to immediate family members.




The goal of the Annual Families Impact Dinner is:

- 1. To pay tribute to the hit and run driving victim.
- Bring families together to show love and support to others who experience similar tragedies.
- Start the process of healing amongst family members.
- 4. Educate and inform supporters and donors on hit and run statistics, real life cases, and meet sponsored families.

2018 ACCOMPLISHMENTS

- Fighting H.A.R.D. approached the first year with great success. Several
 media appearances targeted our branding and awareness arm of the
 organization, resulting in visibility, credibility and a high-profile cause
 worthy of investment. Shortly into its inception, Fighting H.A.R.D. was
 honored by St. Louis City Board of Alderman for efforts and support of
 other families and raising awareness to hit and run fatalities. <u>Fighting</u>
 HARD City of St Louis Resolution Number 82
- Since inception, Fighting H.A.R.D. created community resource partnerships with United Way 211, Walmart, Amazon Smile, St. Louis County Police, Father Support Center, St. Louis City Police. Specifically, Officer Roxanne Ali, (Traffic & Safety Division) is a Fighting H.A.R.D board **member**. Often, she is the first point of contact for families seeking information on a traffic accident resulting in a fatality. She plays a critical role in providing a first-touch resource to families who may require our services. Officer Ali's distribution of the Fighting H.A.R.D. brochures and resources, resulted in an average of 10+ families receiving our services. As a result, we provided legal resources, grief counseling to families such as Maureen Horton, mother of Montez Horton and the Brown Family. (family of Roneisha Calvin)



 New Kansas City, MO Chapter: The mother of Montez Horton, Maureen Horton is our new chapter leader. The entire Fighting H.A.R.D. team met in Kansas City, MO and presented to a total of 12 community leaders and pastors supporting our cause.
